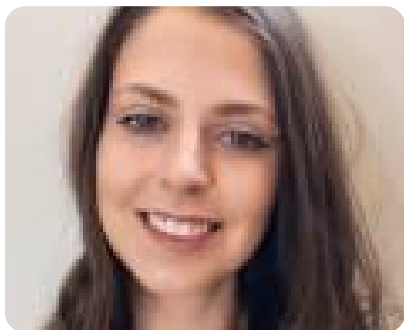


OUR MISSION

IT IS MY PLEASURE TO SUBMIT THIS REPORT ON BEHALF OF THE BOARD FOR 2023.

WITH INCREASES IN THE COST OF LIVING AND INFLATIONARY PRESSURES, IT WAS FISCALLY CHALLENGING FOR THE SOCIETY TO RECEIVE DONATIONS, AND WE GREATLY APPRECIATE THOSE SUPPORTERS THAT ENABLED US TO PROVIDE FREE COUNSELLING SERVICES TO PEOPLE IMPACTED BY INTIMATE PARTNER VIOLENCE. THANK YOU FOR YOUR CONTINUED SUPPORT.

OUR BOARD IS ONE OF GOVERNANCE AND WE RELY ON OUR EXECUTIVE DIRECTOR TO CARRY OUT THE MISSION AND VISION OF THE SOCIETY. MANY THANKS TO RYLEY FOR HER DILIGENCE IN ENSURING RISEUP'S SERVICES REMAIN AVAILABLE TO THE COMMUNITY. CONGRATULATIONS TO REBECCA FOR ADVANCING TO A PROVISIONAL PSYCHOLOGIST, PROVIDING FIRST CLASS COUNSELLING TO OUR CLIENTS. WE APPRECIATE OKSANA'S WORK IN THE COMMUNITY BY FACILITATING MENTAL HEALTH FIRST AID CLASSES, IN ADDITION TO SCHOOL PROGRAMS CONDUCTED IN COLLABORATION WITH THE RCMP. THANKS TO WORK BY OUR OUTREACH AND PROGRAMS COMMITTEE THAT DEVELOPED THE "RED FLAGS" PROGRAM, WE NOW HAVE VIDEO (WITH ACTORS ALECIA MAEDEL AND LAYNE ZAZALACK) AND PROGRAMS TO BE INCORPORATED INTO BOTH SCHOOL PROGRAMS AND ON SOCIAL MEDIA.

OUR BOARD SAW SOME TURNOVER IN 2023. WITH CHANGES TO THEIR PERSONAL SCHEDULES, WE WERE SORRY TO SEE BRYCE LAVECK, HUNTER GATES, PATRICIA EDWARDS, AND NADINE LEMING MOVE ON TO OTHER OPPORTUNITIES. AMANDA DELORME ALSO RESIGNED, AS HER TERM HAD EXPIRED AND SHE MOVED ON TO A NEW CAREER. WE WISH THOSE WHO LEFT US ALL THE BEST IN THEIR FUTURE ENDEAVOURS AND WE THANK THEM FOR THEIR EFFORTS ON THE BOARD. MEGAN KUTZ JOINED US FOR A SHORT PERIOD BUT SHE, TOO, FELT SHE COULDN'T GIVE RISEUP THE TIME SHE WANTED AND SHE MOVED ON. ALTHOUGH WE LOST SOME GREAT EXPERTISE ON THE BOARD, IT WAS EXCITING TO BE ABLE TO WELCOME THREE NEW BOARD MEMBERS: CHARLIE WEBB WHO IS SKILLED WITH THERAPY, SHAWN HAGEN WHO PRACTICES LAW AT A FIRM IN EDMONTON, AND KAYLENE MCKINNEY WHO IS A SOCIAL WORKER WITH 10 YEARS OF EXPERIENCE IN THE COMMUNITY. OUR FOCUS FOR 2024 IS BOARD RECRUITMENT AND RETENTION.

THOUGH OUR BOARD WAS SMALL, WE COMPLETED MUCH IN 2023. WE DEVELOPED A GOVERNANCE PROCESS FOR BOARD MEMBERS THAT INCLUDED CLARIFICATION FOR THE RESPONSIBILITIES OF BOARD MEMBERS, A CODE OF CONDUCT POLICY, A CONFLICT OF INTEREST POLICY, EXPECTATIONS FOR THE BOARD EXECUTIVE TEAM AND BOARD COMMITTEE STRUCTURE. WE ALSO DEVELOPED AN EXECUTIVE DIRECTOR EXPECTATIONS AND CONSTRAINTS POLICY SO THAT OUR ED COULD HAVE CLEAR GUIDANCE.

WE ATTENDED BOARD TRAINING PROVIDED BY THE "ALBERTA COMMUNITY SUPPORT NETWORK" THROUGH OUR MEMBERSHIP WITH THE EDMONTON CHAMBER OF VOLUNTEER ORGANIZATIONS (ECVO). THIS WAS AN EXCELLENT OPPORTUNITY FOR OUR NEW BOARD AND OUR EXECUTIVE DIRECTOR TO LEARN ABOUT GOVERNANCE, RESPONSIBILITIES OF BOARD MEMBERS AND THE EXECUTIVE DIRECTOR, AND HOW THE TEAM CAN COLLABORATE TO MAKE THE SOCIETY SUCCESSFUL. WE LEARNED THAT, WHILE OUR STRATEGIC PLAN IS GOOD, WE NEED TO ENSURE IT IS UPDATED IN 2024 AND THAT IT REMAINS CURRENT.

I LOOK FORWARD TO SEEING WHAT 2024 HAS IN STORE FOR THE SOCIETY.

EXECUTIVE DIRECTOR'S LETTER

IN 2023, RISEUP SOCIETY ALBERTA CONTINUED TO OFFER INDIVIDUAL COUNSELLING SERVICES TO THOSE IMPACTED BY INTIMATE PARTNER VIOLENCE IN-PERSON, BY PHONE, AND VIRTUALLY. WE ALSO HAVE CONTINUED TO EDUCATE THE COMMUNITY THROUGH IPV PRESENTATIONS AND PROFESSIONAL DEVELOPMENT. RISEUP'S CLIENTELE CONTINUES TO BE FINANCIALLY LIMITED IN WHAT THEY CAN CONTRIBUTE FOR COUNSELLING, WHICH MAKES IT IMPERATIVE THAT OUR SERVICES CONTINUE TO BE OFFERED AS ACCESSIBLE AS POSSIBLE BY OFFERING THE FIRST SIX SESSIONS FREE. EVEN AFTER THE SIXTH SESSION, MOST OF OUR CLIENTS ARE NOT ABLE TO MAKE FINANCIAL CONTRIBUTIONS TO THEIR THERAPY. AS A CHARITY, WE UNDERSTAND THAT OUR SERVICES ARE UNIQUE AND ARE NEEDED BY THOSE IN OUR COMMUNITY, AND AS A RESULT WE WILL NEVER RESTRICT ACCESS. THE CONTINUED WAVE OF CLIENTS AND DESIRE FOR IPV SPECIALIZED COUNSELLING HAS MADE IT ABUNDANTLY CLEAR THAT WE ARE AN ASSET TO OUR COMMUNITY, AND THEREFORE NEED TO CONTINUE. THIS WAVE OF CLIENTS ACCESSING SERVICES HAS OPENED NEW DOORS OF OPPORTUNITY FOR OUR AGENCY, WHICH INCLUDES OUR PARTNERSHIP WITH THE EDMONTON YWCA. THE YWCA HAS GENEROUSLY PROVIDED OUR STAFF WITH CLINICAL SUPERVISION, WHICH WILL INCREASE THE QUALITY OF SERVICE FOR OUR CLIENTS. IN EXCHANGE FOR SUPERVISION, RISEUP CURRENTLY PROVIDES THERAPY SUPPORT TO HELP BRIDGE THE GAP FOR CLIENTS IN EDMONTON.

IN TERMS OF FUNDRAISING, RISEUP ENGAGED IN VARIOUS CREATIVE ENDEAVOURS IN 2023. SOME OF THOSE TO HIGHLIGHT INCLUDE THE COLLABORATIVE EVENT WITH THE LEDUC ARTS FOUNDRY, WHERE RISEUP CLIENTS WERE INVITED TO CREATE ART TO SHOWCASE THE IMPACTS OF IPV AS MEANS TO SPREAD AWARENESS IN OUR COMMUNITY. ANOTHER FUNDRAISER WAS OUR FIRST ADVENT CALENDAR FUNDRAISER DURING THE HOLIDAY SEASON. LASTLY, WE WERE EXCITED TO BE ONE OF THE CHARITIES SELECTED AS THE BENEFICIARIES OF THE EDMONTON INTERNATIONAL AIRPORT GOLF TOURNAMENT IN SEPTEMBER. THE SUCCESS OF FUNDRAISERS IS ALWAYS CREDITED TO OUR COMMUNITY SUPPORTERS, VOLUNTEERS, AND EVENT SPONSORS. WE CONTINUE TO RECEIVE STEADY SUPPORT FROM TIER 3 I.T. SOLUTIONS, LEDUC/ BEAUMONT SHOPPERS DRUG MART, AND FROM OTHER CORPORATE/ INDIVIDUAL DONATIONS. THE RECEIVING OF GRANTS HAS ALSO BEEN FUNDAMENTAL IN OUR EFFORTS TO KEEP OUR MANDATE GOING. ALL OUR SUPPORTERS AND FUNDERS WILL BE PROUDLY HIGHLIGHTED IN THIS REPORT.

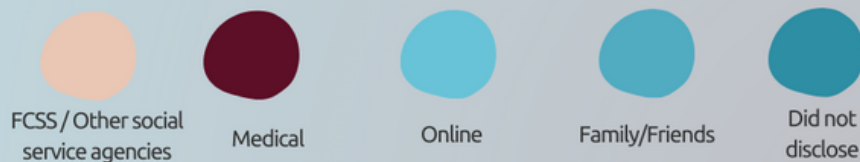
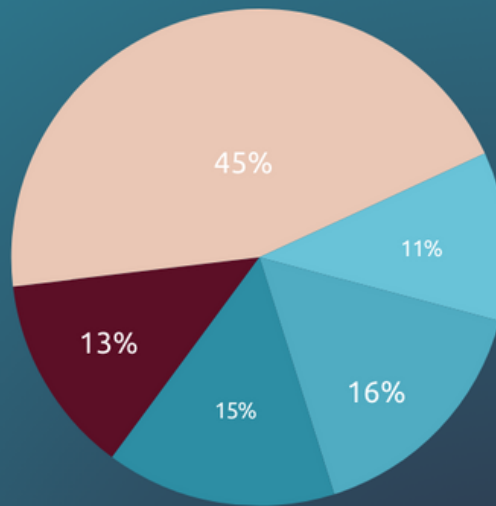

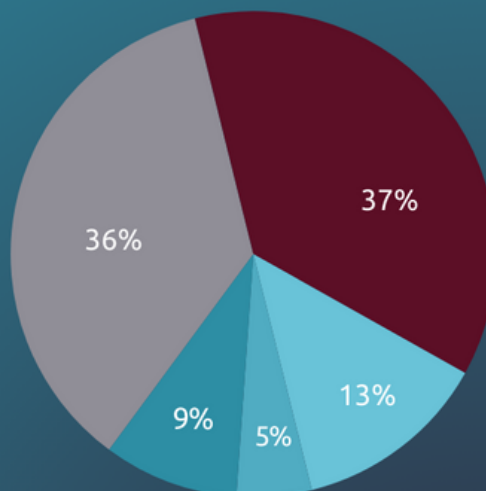

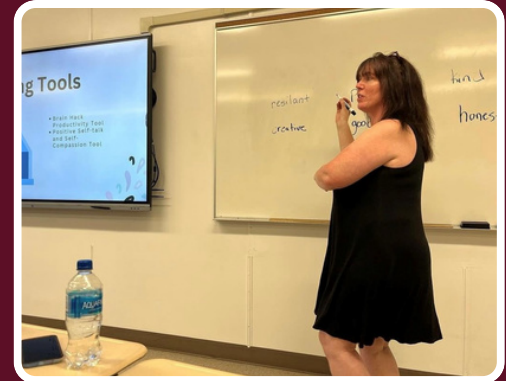

TREASURER'S LETTER

RISEUP SOCIETY ALBERTA (RISEUP) REMAINED IN POSITIVE FINANCIAL HEALTH IN 2023 WHILE FACING THE CONTINUED RIPPLE EFFECTS OF THE PANDEMIC AND THE CHANGING ECONOMY. IN 2023, WE HEARD FROM OUR COMMUNITY THAT NOW MORE THAN EVER, THE SERVICES PROVIDED BY RISEUP ARE CRITICALLY IN NEED AT A FREE OR LOW COST TO CLIENTS. RISEUP IS ABLE TO CONTINUE TO CREATE POSITIVE CHANGE IN THE COMMUNITY AND SUPPORT INDIVIDUALS IMPACTED BY INTIMATE PARTNER VIOLENCE WITH THE SUPPORT OF THE COMMUNITY.

IN 2023, RISEUP DIVERSIFIED OUR FUNDRAISING REVENUE WITH NEW AND CREATIVE INITIATIVES AND PARTNERSHIPS. RISEUP PARTNERED WITH THE LEDUC ARTS FOUNDRY TO HOLD A SUCCESSFUL EVENT CENTRED AROUND THE HEALING POWER OF ART. WE BEGAN A NEW FUNDRAISING INITIATIVE FOR THE HOLIDAY SEASON: AN ADVENT CALENDAR. WE WERE ALSO ONE OF THE BENEFITING CHARITIES FOR THE EDMONTON INTERNATIONAL AIRPORT (EIA) ANNUAL CHARITY GOLF TOURNAMENT.

RISEUP'S FINANCIAL HEALTH IS POSITIVELY SUPPORTED BY LOCAL GRANTS. IN 2023, RISEUP RECEIVED SIGNIFICANT OPERATING GRANTS FROM BEAUMONT FCSS, THE CITY OF LEDUC AND LEDUC COUNTY. WE WOULD LIKE TO EXTEND A WARM THANK YOU TO ALL OF OUR CORPORATE AND INDIVIDUAL DONORS, COMMUNITY PARTNERS, AND THOSE WHO MAKE IT POSSIBLE FOR RISEUP TO CONTINUE POSITIVE FINANCIAL HEALTH.

RISEUP'S BOARD OF DIRECTORS DECIDED TO CONTINUE TO WORK WITH OES GROUP FOR OUR 2023 FINANCIAL REVIEW. PRESENTED IN THIS REPORT AND TO FOLLOW ARE FINDINGS FROM THE 2023 FINANCIAL REVIEW.

STATEMENT OF FINANCIAL POSITION: AT THE END OF 2023, RISEUP SOCIETY ALBERTA IS IN A POSITIVE FINANCIAL POSITION. THROUGH FUNDRAISING, DONATIONS, AND GRANTS, RISEUP WAS ABLE TO PROVIDE POSITIVE REVENUE TO CONTINUE TO OPERATE. REVENUE GAINED IN 2023 WAS USED TO SUPPORT THE SOCIETY'S OPERATIONAL COSTS AND CONTINUE TO DRIVE THE MISSION. RISEUP TAKES A FISCALLY CONSERVATIVE APPROACH IN TIMES OF AN UNKNOWN OR NEGATIVE ECONOMIC LANDSCAPE. WE WILL CONTINUE TO STRIVE FOR POSITIVE FINANCIAL HEALTH IN 2024.

PROCEDURES: RISEUP SOCIETY ALBERTA HAS CONTRACTED BOOKKEEPING SERVICES WITH KING BUSSINESS SOLUTIONS. THIS PROVIDES PISEUP SOCIETY WITH EXTERNAL SUPPORT AND FINANCIAL SAFETY. BANK RECONCILIATION HAPPENS MONTHLY, AND FINANCIAL STATEMENTS ARE REVIEWED MONTHLY BY THE RISEUP BOARD OF DIRECTORS TREASURER AND WITH THE BOARD OF DIRECTORS AT MONTHLY BOARD MEETINGS.
